On November 1, 2023, Puget Sound Energy, (PSE or Company) filed a Biennial Update to their Clean Energy Implementation Plan (CEIP).<sup>1</sup> The CEIP is a plan that outlines how PSE will transition to clean energy by 2045 and how this change benefits customers.
