Q2 2023 Quarterly PCAM Report (January 2023 through June 2023)

PacifiCorp dba Pacific Power and Light Company (PacifiCorp or Company) submits its Q2 2023 Power Cost Adjustment Mechanism (PCAM) quarterly report in accordance with Order 01 in Docket UE-210447 dated September 30, 2021. Specifically, Ordering Paragraph 3 requires PacifiCorp to "provide quarterly reports on PacifiCorp d/b/a Pacific Power & Light Company's PCAM deferral balance beginning December 15, 2021".

The allocation factors used in this Q2 2023 report for calendar year 2023 are preliminary, subject to change, and are currently based on the 12 months ended June 2023. Allocation factors for calendar year 2023 have not yet been finalized. The Company's annual PCAM filing for calendar year 2023, due to be filed with the Washington Utilities and Transportation Commission in June 2024, will reflect final calendar year 2023 allocation factors.

Confidential work papers are provided in accordance with WAC 480-07-160. The confidential work papers include valuable commercial information, specifically confidential cost and financial information associated with loads and pricing. Disclosure of such information would harm PacifiCorp by an unfair competitive disadvantage.
