It has come to the attention of Northwest Industrial Gas Users' (NWIGU) counsel that the transcript (Andrews on p. 573, line 22, copy attached) reflects an uncorrected transcript error to which NWIGU referred in its Post-Hearing Brief (Board Valentine costs of nearly "\$9,000"). Avista's Board Valentine candy cost \$87.50 rather than \$8,750 according to an Avista response to Staff data requests. Numerous other excessive expense items for Avista's Board were the basis of Staff's and Public Counsel's proposed adjustments to the test year expense. NWIGU supports those adjustments as recommended by Staff and Public Counsel, but in doing so NWIGU does not want to present an inaccurate transcript quote to the Commission.
