Dear Mr. Rathbun:

On March 18, 1998 the Commission entered its Order Accepting Stipulation; Requiring Tariff Refiling under Docket No. UG-971136 for service to Kittitas County. Final completion of Phase I of the project occurred in 1999. On February 18, 2005 the Commission entered its Fourth Supplemental Order Amending Order Accepting Stipulation to address issues pertaining to the pipeline route and diameter for Phase II.

PSE seeks to further amend the order as it pertains to the pipeline route for Phase II of the project. Exhibit A reflects our new proposed route.

As shown in this exhibit, the pipeline will cross the John Wayne Trail at McDonald Road. In addition, a portion of the pipeline will be constructed on and adjacent to WSDOT property including near the Indian John Hill rest area. However, the pipeline will be greater than 100 feet away from the developed portion of this rest area. No other well-defined outside areas lie within 100 feet of the proposed right of way. Exhibit B is a list of structures within 100 feet of the proposed pipeline along this route.
