As an aging coal-fired power plant, Colstrip has several environmental and public health issues that the WUTC should take into consideration when reviewing PSE's Integrated Resource Plan (IRP).

PSE can do better, especially considering that coal is the worst-polluting of fossil fuels and considering increasing problems of global warming and climate change. In addition, CO2 has been designated as an air pollutant by the U.S. Supreme Court.

It's well known that Colstrip's waste-water impoundments have been leaking and contaminating the underlying aquifer for decades.
