TO THE PREFILED DIRECT TESTIMONY  
OF LYNN F. LOGEN**

**Q. Please state your name and business address.**

A. My name is Lynn F. Logen. My business address is 10885 NE Fourth Street, Bellevue, WA 98009-9734.

**Q. By whom are you employed and in what capacity?**

A. I am employed by Puget Sound Energy, Inc. (“PSE”) as Supervisor of Tariffs. I have been employed by PSE and its predecessor since August 1971 and have been in my current position since March 1997. Prior to March of 1997 I was employed by Puget Sound Power & Light Company as Manager of Rates and Tariffs.

**Q. What are your duties as Supervisor of Tariffs?**

A. I am responsible for directing the implementation and administration of the electric and gas tariffs, the development of new and revisions of existing tariffs and contracts, the communication of policy, strategy and operating practices to employees within PSE and to customers. I am also responsible for the development, negotiation and drafting of service area agreements with other

1 electric utilities. I issue rate interpretations, contractual agreements and rules of  
2 service.

3 **Q. Briefly describe your education and experience prior to your employment at**  
4 **PSE.**

5 A. I attended Washington State University from 1966 through 1971 prior to  
6 becoming employed at PSE. Prior to that I assisted in studies by the Whitman  
7 County Port District and did volunteer work at Inland Power and Light Company.

8 **Q. Briefly describe your education and experience while at PSE.**

9 A. I have attended four programs relating to utility regulation at New Mexico State  
10 University and have participated in and made presentations at NW Utility  
11 regulatory group meetings and made a presentation to the national Illuminating  
12 Engineering Society on street light tariffs. I have represented PSE in general rate  
13 case settlement discussions (UE-011570), rulemaking proceedings and numerous  
14 individual tariff filings and several formal complaints (most recently in Docket  
15 No UE-091531).

16 **Q. Have you appeared before the Commission in other matters?**

17 A. While I have not previously appeared on behalf of PSE as a witness, I have  
18 attended several Commission hearings and open meetings. Further, I appeared  
19 pro se in Docket No. TR-090121 in opposition to BNSF Railway Company's  
20 application to close the Logen Road crossing.
