As a resident of King County and as a customer and ratepayer of gas and electric services provided by Puget Sound Energy, I urge PSE to include in its long-term plan a provision for the goal of 100% clean and sustainable energy instead of that produced by burning fossil fuels. In order to accomplish that, a first step is to set a deadline of 2025 for the closing of Plants 3 and 4 at Colstrip Electric Power Plant. This is crucial.
