- JDW-24CTr at 20:1: a "2" is added after "Table" and the "3" is struck.

- JDW-24CTr at 24:2 and 24:5: “Table 1” changed to “Table 3.”
- JDW-24CTr at 24:6-25:5: preserved content from deleted section III is added.
- JDW-24CTr at 26:1-19: preserved content from deleted section III is added.
- JDW-24CTr at 27:10: a “2” is added after “Table” and the “3” is struck.
- JDW-24CTr at 27:11: the “3” after “Table” is struck and “2” is added.
- JDW-24CTr at 27 line 11, starting with “If the” through line 15 is struck.
