What a pleasant surprise to get an email just to say hello and share your love of us Dakotans here in the real Dakota. We still like hearing from you, even if you need something, although I think it is the other way around as far as I am concerned. You have way more knowledge than I do and I am likely the one reaching out to you!

Here's a quick update in lieu of a Christmas letter. We are moving full steam ahead on releasing a RFP after the first of the year. While none of us ever wants to broadcast this, we have had several outages with Comtech over the past couple of months which has prompted our board to take action. As of this week, we migrated the remaining 3 PSAPs back off ESInet. So.....we are sort of back where we started years ago with all of our PSAPs on the legacy CenturyLink network. Shortly before this, we had already sent a change request to Comtech to stop any further efforts with regard to carrier migration, ALI migration and Text to 9-1-1 due to the ongoing issues we were having with rural carrier interconnection. We didn't see any way they would be able to get done what they said they would by the end of their contract this time next year, so we started working on a RFP.

We hope your transition continues to inch forward successfully. I am sure Comtech is keeping South Dakota news away from your project!
