12	Q.	WHAT IS THE PURPOSE OF YOUR REBUTTAL TESTIMONY?
13	А.	I am providing rebuttal testimony concerning certain operational issues and proposed
14		conditions raised in testimonies in the proceeding before the Washington Utilities and
15		Transportation Commission ("Commission") related to the proposed merger (the
16		"Transaction") of Qwest Communications International, Inc. ("Qwest") and CenturyLink.
17		Specifically, I will address the testimonies of Mr. Mark J. Vasconi <sup>1</sup> and Ms. Jing Liu <sup>2</sup>
18		who provided testimony on behalf of the Staff of the Commission ("Staff").

# Q. STAFF WITNESS VASCONI RECOMMENDS CENTURYLINK BE REQUIRED TO FILE A STRATEGIC PLAN EVALUATING ITS SWITCHES<sup>3</sup> IN WASHINGTON AND PROVIDING A PROPOSED REPLACEMENT PLAN IF NECESSARY (CONDITION 12). IS SUCH A PLAN NECESSARY?

5 A. No. CenturyLink's switches in Washington currently support the provision of quality 6 service to customers, including advanced services. There currently are no technological 7 or service triggers that would cause us to replace these switches within the near future. 8 Technological advancements in digital switching have reached a point where switch 9 functionality is primarily controlled through software changes and upgrades rather than through physical hardware. Additional functionality to increase efficiency, expand 10 11 capacity, or offer new and advanced services is often accomplished through upgrades to 12 the software of the switch rather than a physical change-out of the switch. Technology 13 continues to advance allowing for multiple options to address long term solutions for 14 customers. CenturyLink routinely reviews the status of network elements and works to 15 ensure customer impacting exposures, as well as desired functionalities, are part of the 16 analysis. The Commission should not require CenturyLink to commit resources to 17 develop a plan for switch replacements when there is currently no need for such switch 18 replacements. Additionally, because of the rapidly evolving technologies, any plan built 19 long before a trigger event occurred would likely need to be redone so that it can take 20 into account relevant technological changes.

# Q. DID THE STAFF PROVIDE ANY TESTIMONY TO SUGGEST THAT THE TECHNOLOGICAL OR SERVICE "TRIGGERS" YOU DISCUSSED ABOVE WOULD NECISSITATE SWITCH REPLACEMENTS FOR CENTURYLINK OR OWEST IN WASHINGTON?

No. Although Mr. Vasconi includes this condition as one he is sponsoring,<sup>4</sup> I could find 5 A. 6 no discussion in his testimony of the rationale or need for this condition. I also reviewed 7 the testimony of Staff witness Kristen Russell, who discusses service quality issues and 8 found no discussion of any service deficiencies that would necessitate a comprehensive 9 switch change-out plan contemplated by Staff condition 12. In fact, Ms. Russell's 10 analysis of CenturyLink's and Qwest's service quality lead to her conclusions that 11 CenturyLink and Qwest generally meet the Commission's service quality benchmarks 12 and that Staff had no overriding concerns about the companies' current quality of service.<sup>5</sup> 13

## **POSITION ON BROADBAND EXPANSION?**

A. Yes. CenturyLink witness John Jones addresses this condition from a policy
perspective. From an operations perspective, CenturyLink has been investing in a
broadband-capable infrastructure with the overall goal of increasing the availability of

1		broadband service while also increasing broadband speeds in areas where broadband
2		service already exists. After the merger, the combined company will continue to invest in
3		bringing robust broadband services to its Washington customers. CenturyLink is a
4		broadband leader in the areas it serves. Broadband services provide an opportunity to
5		improve the lives and welfare of the customers and businesses in these areas. Economic
6		development, education, healthcare, and government services all benefit from the
7		effective use of broadband networks, but these benefits must be balanced with the cost of
8		deployment. CenturyLink is proud of its historical commitment to build and operate
9		broadband networks. However, the economic factors to deploy broadband services in the
10		highest cost, lowest population density areas are challenging as there are too few
11		consumers living in these areas to cover the costs of building and providing advanced
12		network services. Despite these economics, CenturyLink has been a leader in providing
13		broadband services and will continue to seek innovative solutions that allow the
14		Company to expand the reach of its high bandwidth services.
