### 5 Q. BY WHOM ARE YOU EMPLOYED AND IN WHAT IS YOUR POSITION?

- 6 A. I am employed by GTE Service Corporation as Program Manager, Access Services and
- 7 am representing GTE Northwest Incorporated ("GTE") in this proceeding.

## Q. PLEASE SUMMARIZE YOUR EDUCATIONAL BACKGROUND AND

10 EXPERIENCE.

- 11 A. I graduated from the University of Missouri Columbia in 1982 with a Bachelor of Arts
- degree in Mathematics and Statistics. My employment with GTE commenced in May
- 13 1982 in the Network Planning Department. I held several positions during my first six
- 14 years with Network Planning. My responsibilities included capital budgeting, capital
- portfolio management, implementation of enhanced support products for Network
- Planning, and coordination of technical responses for business customer requests. In
- 17 1988, I moved into the Business Pricing group and remained there for four years. My
- responsibilities there included pricing new network services for tariff offerings, as well
- 19 as pricing individual case applications.

- 21 In December 1992, I became the Product Manager for Expanded Interconnection
- 22 Services. My responsibilities included coordinating GTE's response to the FCC's
- 23 Docket 91-141 Order on Special Access and Switched Transport Interconnection, a task

### Q. WHAT IS THE PURPOSE OF YOUR TESTIMONY?

15 A. The purpose of my testimony is to respond to the Commission's invitation in the 17th

16 Supplemental Order for comment on the "scope of third party provisioning of

17 collocation in light of the FCC's finding that cageless collocation must be provided by

18 ILECs." 17th Supplemental Order: Interim Order Determining Prices; Notice of

19 Prehearing Conference (September 23, 1999), Docket Nos. UT-960369, 960370,

20 960371, ¶291.

## 1 Q. WHAT IMPACT DOES THE FCC'S ADVANCED SERVICES ORDER! HAVE

### 2 ON THIRD PARTY PROVISIONING OF COLLOCATION?

- 3 A. The same rules surrounding third-party provision of caged collocation should apply to
- 4 the cageless arrangements that have become available as a result of the Advanced
- 5 Services Order.

## 7 Q. WHAT IS GTE'S POLICY WITH REGARD TO THIRD PARTY

### PROVISIONING IN A CAGED OR CAGELESS ARRANGEMENT?

- 9 A. A CLEC may utilize an ILEC-approved contractor to provision certain aspects of their
- 10 caged or cageless collocation arrangement. For example, a CLEC may hire an ILEC-
- approved contractor to perform work within its caged or cageless space provided that the
- work is specific to the CLEC collocation arrangement.

### 14 Q. WHAT CRITERIA DOES GTE USE TO APPROVE CONTRACTORS?

- 15 A. GTE requires that all contractors utilized by GTE or by the CLEC be certified or meet
- the same qualifications as a GTE-certified vendor to perform installation services within
- its central offices. The certification requirements are the same for all contractors or
- 18 CLEC employees performing installation services within GTE's central offices, and
- 19 therefore these requirements are non-discriminatory. Further, GTE will provide, upon
- 20 request by the CLEC, a complete list of all contractors certified to perform installations
- 21 in GTE's central offices, as well as its vendor qualification guidelines. Once a carrier

has been certified, the contractor may perform work for the CLEC or for GTE in any

GTE central office.

- 4 Q. SHOULD A CLEC BE PERMITTED TO HIRE AN ILEC-APPROVED
- 5 CONTRACTOR TO PERFORM WORK OUTSIDE OF THE CAGE OR
- 6 CAGELESS SPACE?
- No. GTE has a responsibility to all of its customers located in or served by a particular 7 central office to ensure safe, smooth and efficient operation of that office. Because 8 9 provisioning of a collocation arrangement affects more than just the collocation space of a particular CLEC, it is imperative that GTE maintain control of and responsibility for 10 the contractor doing work outside the caged or cageless space. GTE control over such 11 12 work will avoid scheduling conflicts, liability issues and will ultimately result in quicker and more efficient installations than if each CLEC directed the contractor's work, 13 without any centralized control. 14

15

- 16 Q. WHAT ARE THE TYPES OF WORK ACTIVITIES OUTSIDE OF THE
- 17 COLLOCATION SPACE THAT NEED TO BE PERFORMED OR
- 18 CONTROLLED BY GTE?
- 19 A. Work activity that may occur outside a CLEC's collocation space and requires GTE control includes work associated with the provisioning of power, space preparation,
- 21 overhead superstructure, and various cabling assignments. Although GTE will
- coordinate this work activity, GTE and the CLEC may mutually agree on utilizing GTE-

certified contractors for these activities or the CLEC may apply to become a certified Į

2 contractor itself.

4 DOES THIS CONCLUDE YOUR TESTIMONY? Q.

5 Yes. A.
