I. STIPULATION

COMES NOW Superior Waste & Recycle, through its attorney Jimmy Garg; Waste Management, through its attorney Walker Stanovsky; and Washington Utilities and Transportation Commission, through its attorney Harry Fukano, stipulate that the WAC 480-70-421 be waived to the extent required for confidential discovery and usage consistent with the protective order entered in this case on April 9, 2019.

WAC 480-70-421 requires that the personal identifying information of customers of a Solid Waste and/or Refuse Collection Company may only be used for providing and billing for services the customer requests, marketing new services or options to its customers, or providing information to its customer. While the rule lists certain exceptions where release of information is allowed, there is no such exception for discovery in an ongoing administrative proceeding before the Washington Utilities and Transportation Commission. Noting that this rule prohibits release of certain information which is required by the parties for their ongoing obligations under this proceeding, all parties herein stipulate to waiver of WAC 480-70-421 for the purposes stated herein.
