1 On November 22, 2024, Waste Management of Washington, Inc (“WMW”) filed the Direct  
Testimony of Chad Brooks, Exhibit CB-1T. WMW hereby submits the following revisions to that  
testimony.

2 On page 2, lines 6 to 7, replace the phrase “I provide” with “through December 31, 2024,  
I provided”.

3 On page 2, line 10, add the following sentence to the end of the answer: “As of January 1,  
2025, I transitioned to covering a new geographic area, maintaining the same role and  
Commission-related functions. I now oversee 20 locations that include all of WMW’s collection  
districts along the Interstate 5 corridor in *Western* Washington, including the Puget Sound region,  
that provide Commission-regulated services.”
