5	For purposes of this chapter:
6	(1) "Local exchange company" means a telecommunications company providing
7	local exchange telecommunications service.
8	(2) "Department" means the department of social and health services.
9	(3) "Washington telephone assistance program" means: the program of local
10	exchange service discounts administered by the department.
11	(a) A discount on residential service connection fees of fifty percent;
12	(b) A waiver of the deposit on local residential exchange service;
13	(c) A discounted flat rate on one access line for local residential exchange
14	service for eligible persons subscribing to the lowest available local exchange flat
15	rate service, where that rate, including any federal end user access charge or
16	other charge necessary to obtain local exchange service, is greater than the
17	telephone assistance rate set by the commission. Where available, single-party
18	service shall qualify as the lowest available flat rate for persons otherwise
19	eligible, who are sixty years of age or older, or who receive
20	medical assistance.
21	(4) "Eligible person" means an adult recipient of department-administered
22	programs for the financially needy which provide continuing financial or medical
23	assistance, food stamps, or supportive services to persons in their own homes.
24	The department shall notify the participants of their eligibility.
25	(5) "Eligibility period" means a one-year period of eligibility as certified by the
26	department. The eligibility
27	period shall run from July 1 through June 30 of the succeeding year.
28	(6) "Charge necessary to obtain local exchange service" means the charge for
29	the lowest available grade of residential flat rate service, any federal end user
30	access charge, any charge for nonoptional extended area service and any

31 charge for nonoptional mileage. It does not include any charge for customer 32 premises equipment or any applicable taxes. 33 (4) "Switched access line" means, for the purpose of applying the telephone 34 assistance program excise tax, a communication facility extending from a serving central office to a customer's premises to provide access to and from the 35 36 switched telecommunications network for message toll service and local calling. 37 When used with PBX or Centrex-CU a switched access line may also be referred 38 to as a trunk. 39 (8) "Connection fees" means any service charge applicable to the connection of 40 a switched access line to establish new service, but not including line extension 41 charges or any delinquent balance owed to the local exchange company. 42 (5) Radio communications service company has the meaning found in 43 80.04.010 RCW, except that for the purposes of this section it includes only 44 those companies providing two-way voice communication as a common 45 carrier. 46 (6)"Eligible telecommunications carrier" (ETC) means a carrier designated 47 as an ETC pursuant to 47 U.S.C. 214(e). 48 49 IStatutory Authority: RCW 80.01.040. 90-19-020 (Order R-328, Docket No. UT-50 900462), § 480-122-010, filed 9/11/90, effective 10/12/90; 87-20-043 (Order R-51 277, Cause No. U-87-1102-R), § 480-122-010, filed 10/1/87.] 52 53 54 WAC 480-122-020 Washington telephone assistance program rate. 55 The commission shall set by order the telephone assistance rate to be paid by 56 program participants for local service. Every eligible telecommunications 57 carrier (ETC) must offer the telephone assistance rates and discounts in 58 accordance with RCW 80.36.410 through 475. Every non-ETC local 59 exchange company must offer the telephone assistance rates and 60 discounts in accordance with RCW 80.36.410 through 475 when 100 or

more of its access lines are subscribed to for residential service. Radio

A subscriber may choose to pay the 80 connection fee in a lump sum. Each party line subscriber customer shall be assessed the 119 telephone assistance excise tax in full. The telephone assistance excise tax shall 120 be separately identified on each ratepayer's bill as the "Washington telephone 121 assistance program." Money collected from the telephone assistance excise tax 122 shall be transferred to a telephone assistance fund administered by the 123 department.

- 179 (b) The date on which the local exchange company first receives confirmation
- 180 from the department that said person is an eligible subscriber.
- 181 (2) A local exchange company shall not continue telephone assistance program
- 182 benefits to any person for whom renewed certification has not been received by
- 183 the company from the department beyond the expiration of the eligibility period
- 184 for which the company has most recently received certification.
