Jones & Co., L.P, Janney Montgomery Scott LLC, Stifel, Nicolaus & Company Incorporated and Wells Fargo Securities, LLC, as representatives of several underwriters, at a price to the Company of \$29.99 per share, resulting in total proceeds, before expenses, of \$38,687,100. The underwriters initially offered the Common Stock to the public at a price of \$31.00 per share.
