- 1 On March 1, 2006, Iliad Water Service, Inc. (Iliad Water) filed with the Commission a revision to its currently effective Tariff WN U-1, designated as Original Sheet No. W-104, instituting a one-time assessment collectable from the customers of the Alder Lake Community Water System. The operation of such tariff revisions has been suspended by order of the Commission pending hearing or hearings concerning such changes and the justness and reasonableness thereof.

- 2 The Commission will hear this matter pursuant to Part IV of chapter 34.05 RCW pertaining to adjudicative proceedings, including but not limited to RCW 34.05.413, RCW 34.05.422, RCW 34.05.431, RCW 34.05.440, RCW 34.05.449, and RCW 34.05.452. Statutes involved, in addition to those previously cited, include those within chapters 80.01 RCW, 80.04 RCW and 80.28 RCW, including but not limited to RCW 80.01.040, RCW 80.04.130, RCW 80.28.010, RCW 80.28.020, RCW 80.28.030, RCW 80.28.040, RCW 80.28.060 and RCW 80.28.100. Rules involved include those within chapters 480-07 WAC, and chapter 480-110 WAC.

- 3 The ultimate issues include 1) whether the tariff revision to increase the amount collected is just and reasonable; 2) whether existing rates are fair, just reasonable, and sufficient and 3) whether the purity, volume, and pressure of water supplied is sufficient, pure, or adequate. In accordance with the provisions of RCW 80.04.130 the burden of proof to show that the increase is just and reasonable will be upon the respondent.

4 **PLEASE NOTE:** The commission understands that the parties are working together to reach agreement on issues that separate them, and it supports your efforts. We set the prehearing conference schedule to allow you nearly two months to discuss and resolve differences. If you are unable to reach agreement, the conference will determine a hearing schedule to resolve the issues promptly and within the statutory suspension period.

5 **THE COMMISSION GIVES NOTICE That a prehearing conference in this matter will be held at 1:30 p.m., on June 7, 2006, in Room 108, Chandler Plaza Building, 1300 S. Evergreen Park Drive S.W., Olympia, Washington.**

6 The purpose of the prehearing conference is to take interventions, establish dates for distribution of evidence and workpapers and other scheduling matters, consider formulating the issues in the proceeding and to determine other matters to aid in its disposition, as specified in WAC 480-07-430.

7 Petitions to intervene should be made in writing at least three business days prior to the date scheduled for the prehearing conference, as required in WAC 480-07-355(a). The commission will consider petitions to intervene made orally during the conference, but strongly prefers written petitions to intervene. In addition, party representatives must file notices of appearance with the commission, as required by WAC 480-07-345(2), no later than the day prior to the conference. If any party or witness needs an interpreter or other assistance, please fill out the form attached to this notice and return it to the commission. The time and place for any evidentiary hearings will be set at the prehearing conference, on the record of a later conference or hearing session, or by later written notice.

8 **THE COMMISSION GIVES NOTICE that any party who fails to attend or participate in the prehearing conference set by this Notice, or any other stage of this proceeding, may be held in default in accordance with RCW 34.05.440. The parties are further advised that the sanction provisions of WAC 480-07-450 are specifically invoked.**
