1. The Commission finds good cause to support the request and authorize the proposed changes to become effective with Less Than Statutory Notice on: September 1, 2007.
2. The proposed changes will expire on: January 31, 2008.
3. The temporary 1.94% fuel surcharge in all rates and charges is the result of increased fuel costs incurred by the company during the months of May, June and July 2007 to be collected from customers as follows:
4. This Supplement No. 5 cancels Supplement No. 4.
5. For customers who are billed monthly for services in arrears, the fuel surcharge applies to all services provided in the months of September, October and November 2007. Customers who are billed quarterly for services – One month in arrears, current month and one month in advance:
