On March 28, 2013, Northwest Natural Gas Company (NWN) filed its 2013 Integrated Resource Plan (IRP or Plan) for natural gas service with the Washington Utilities and Transportation Commission (Commission) pursuant to WAC 480-90-238. An IRP for gas service describes the mix of natural gas supply and conservation that will meet both the current and future gas demands at the lowest cost to the utility and its ratepayers.
