- On October 15, 2013, the Washington Utilities and Transportation Commission (Commission) issued Penalty Assessment TE-131923 against 2C Captains, Inc. d/b/a Let's Tour Seattle (Let's Tour Seattle or Company) in the amount of \$7,900, finding 79 violations of WAC 480-30-221, Vehicle and driver safety requirements, which requires passenger transportation companies to comply with Title 49, Code of Federal Regulations (CFR), including Part 391 Qualifications of drivers and Part 396 Inspection, repair, and maintenance.
- On October 30, 2013, Let's Tour Seattle filed with the Commission a request for hearing to present evidence and argument supporting mitigation of the assessed penalty.
- On November 12, 2013, Commission Staff (Staff) filed a response stating that it opposes mitigating the \$7,900 penalty assessment and that it will testify about its recommendation at hearing.
- In accordance with RCW 34.05.482 and WAC 480-07-610, the Commission determines that a brief adjudicative proceeding is appropriate for determining whether to mitigate the penalty the Commission assessed for the violations of WAC 480-30-221.
