The purpose of this substitute filing is to extend the effective date of the filing to October 17, 2014, in order to allow PSE to provide additional information to the Commission Staff regarding the issues of first impression and effective competition. PSE has conducted some additional investigation into these topics and may have found, (1) some evidence of potential precedence in Docket No. UE-961117, and (2) a large number of competitive non-energy suppliers selling RECs as evidenced by the following list from the U.S. Department of Energy, Green Power Network:


