- On March 30, 2015, the Washington Utilities and Transportation Commission (Commission) issued a Penalty Assessment in Docket DG-150491 against Tom Wise, Tank Wise LLC (Tank Wise or Company) in the amount of \$2,000, alleging 2 violations of RCW 19.122.030(1)(a) by failing to request a dig ticket prior to performing an excavation.
- On April 9, 2015, Tank Wise filed with the Commission a request for hearing on the form provided by the Commission. Tank Wise checked the box on that form indicating that the Company admits to the violations, but request a hearing to present evidence.
