The State of Washington to Dolly, Inc.:

You must appear before the Washington Utilities and Transportation Commission (Commission), 1300 S. Evergreen Park Drive, S.W., Olympia, Washington, 98504-7250 at the special proceeding referenced in the attached Order and Notice of Hearing at 9:30 a.m., on March 13, 2018, in Room 206, Richard Hemstad Building, 1300 S. Evergreen Park Drive S.W., Olympia, Washington, and give testimony and evidence under oath as to the operations of Dolly, Inc. pursuant to RCW 34.05.446, RCW 80.01.060(1), and RCW 81.04.510.

You must bring with you the following documents:

- A. For a company seeking to avoid further enforcement action by ceasing unpermitted operations and leaving the industry, you must bring sufficient documentation or records to demonstrate closure of your unpermitted household goods carrier business. For example, those papers might include documentation from (1) the Secretary of State's office for dissolution of your business entity; (2) the Department of Licensing for cancellation of your business license; (3) your internet service provider (or equivalent) showing cancellation of a website or e-mail account; (4) your telephone provider showing cancellation of your corporate telephone number; (5) proof of cancellation of your company advertising; and (6) sales receipts for any company equipment sold in the process of shutting down and closing.
- B. For a company seeking to obtain the required permit and come into compliance with all other regulated companies in the industry, you must bring a completed application for passenger transportation authority and all

records necessary to support the application, per WAC Chapters 480-14, 480-15, and 480-70, including (1) a complete application filing as required by WAC 480-14-180, WAC 480-15-186, and WAC 480-70-091; and (2) proof of insurance as required by WAC 480-14-250, WAC 480-15-530 and WAC 480-15-550, and WAC 480-70-.

In lieu of producing these documents at the proceeding, you may mail a copy of the subpoenaed documents together with your certification that the items produced are true and correct copies of the subpoenaed documents to:

If you choose to produce the subpoenaed documents by mailing them rather than producing them at the hearing, the Commission must receive the subpoenaed documents before the date set out above for the hearing or you will not have complied with this subpoena.
