## RATE INCREASE NOTICE FOR RESIDENTIAL GARBAGE AND RECYCLING

Dear Customer:

November 30, 2018

Murrey's Disposal Co., Inc. has filed a request for a rate increase with the Washington Utilities and Transportation Commission (WUTC). The last general rate increase was approved by the WUTC June 1, 2016. Since that time, we have experienced higher costs for employee wages, benefits, fuel, truck equipment and have completed facility improvements.

If approved, the proposed rates below will become effective January 1, 2019. The rate per pick-up will increase as follows:
