- 1 On December 5, 2018, Bremerton Kitsap Airporter, Inc. d/b/a The Sound Connection and Ft. Lewis McChord Airporter (BKA or Company) filed with the Washington Utilities and Transportation Commission (Commission) an application for extension of Certificate C-903 for authority to provide service between Fort Lewis, McChord Air Force Base, Lakewood Holiday Inn Express, and the Seattle-Tacoma International Airport (Sea-Tac) via I-5 and SR 99, including connecting streets and roads.
- 2 On December 12, 2018, the Commission issued a docket notice to interested persons that provided 30 days to protest the application filing.
- 3 On January 11, 2019, Pacific Northwest Transportation Services, Inc., d/b/a Capital Aeroporter Airport Shuttle (Capital Aeroporter) filed an Objection to Extension of Existing Auto Transportation Certificate C-903 Application (Objection). In the Objection, Capitol Aeroporter claims that it operates scheduled service between the Lakewood Holiday Inn Express and Sea-Tac, and that BKA’s requested service would overlap Capital Aeroporter’s existing authority.
- 4 Pursuant to RCW 34.05.482, WAC 480-07-610, WAC 480-30-140, and WAC 480-30-136 the Commission determines that a brief adjudicative proceeding is appropriate for resolving the issues in this matter.
- 5 **THE COMMISSION GIVES NOTICE That it will hold a brief adjudicative proceeding in this matter at 9 a.m. on Monday, March 18, 2019, in Room 206, Richard Hemstad Building, 1300 S. Evergreen Park Drive S.W., Olympia, Washington.**

- 6 The record in this case will consist of any documents regarding the matter that are considered by or prepared for the presiding officer for the brief adjudicative proceeding and a transcript of any oral statements given at the hearing, which statements will be given under oath.
- 7 The Commission will provide at its offices in Olympia, Washington, copies of documents in the current record for use by the parties or others who may want to review them.
- 8 In accordance with WAC 480-30-136(2), the Commission requests that the parties file by **5 p.m., March 11, 2019**, the following additional documents for consideration at the brief adjudicative proceeding:
- (1) Statements from independent witnesses provided by an objecting company to demonstrate that the objecting company is providing, to the Commission's satisfaction, the same service as the proposed service.
  - (2) Statements from independent witnesses provided by an objecting company to demonstrate that the traveling public will be harmed if the application is granted.
  - (3) Additional supplementary information, evidence, or testimony provided by the applicant to demonstrate that public convenience and necessity requires the proposed service.
- 9 The Commission also requests that each party file all documents the party intends to offer at hearing, as well as an exhibit list enumerating and describing such documents, **no later than 5 p.m. on Monday, March 11, 2019**. Filing shall be in accordance with WAC 480-07-140.
- 10 **THE COMMISSION GIVES NOTICE that any party who fails to attend or participate in the brief adjudicative proceeding set by this Notice, or any other stage of this proceeding, may be held in default under RCW 34.05.440 and WAC 480-07-450.**
