SUPPLEMENTAL SCHEDULE 141Y **TEMPORARY FEDERAL INCOME TAX RATE CREDIT**

APPLICABILITY: This rate is applicable to all Customers of the Company and will be applied to all bills to Customers during a month when this schedule is effective.

PURPOSE: The Tax Cut and Jobs Act (the Act), signed into law by President Trump on December 22, 2017, reduced the federal corporate income tax rate from 35% to 21% effective for tax years beginning after December 31, 2017. This temporary schedule passes through to Customers the interim period tax amounts over-collected from January through April, 2018, in accordance with the Commission's Order 05, Final Order Approving Settlement Agreement with Condition in Dockets UE-180899 and UG-180900 (Consolidated).

TERMINATION: The rate credits under this schedule will terminate on April 30, 2020.

TRUE-UP: Following the May 2019 through April 2020 refund period, if the residual balance due to (credit) or owed from (surcharge) all Customers is less than \$100,000 (threshold), the Company will write-off the regulatory liability or asset that is due to or owed from Customers that is below the threshold. If there is a residual balance that is either due to or owed from all Customers that is greater than \$100,000, the Company will submit a filing no later than July 31, 2020 proposing to credit or surcharge Customers the balance effective September 1, 2020 through August 31, 2021. If a residual amount that exceeds \$100,000 remains following the September 2020 12-month period, then the method for determining the disposition of the residual amount will be determined at that time.
