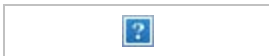

Mike,

I hope you are well. I have some follow up on this issue from last year. It has taken some time to accomplish this rack replacement for a number of reasons.

Anyway, to where I stand today. We had requested a clearance waiver of 18'8" based on information provided by the equipment manufacturer. Apparently, those were only conceptual dimensions. In actuality, they have provided me with a setup that will provide 17'3.25" of clearance. Is there anything that would prevent an amended clearance waiver of that height? If this is problematic, we will need to evaluate other options. One concern is that if we attempt to raise this higher, we may compromise the fall protection dimensions that are necessary per OSHA requirements so we are trying to evaluate the options that we have to meet all the parties needs.

Please advise as to what options we have from your perspective. Feel free to discuss if more clarification is needed.

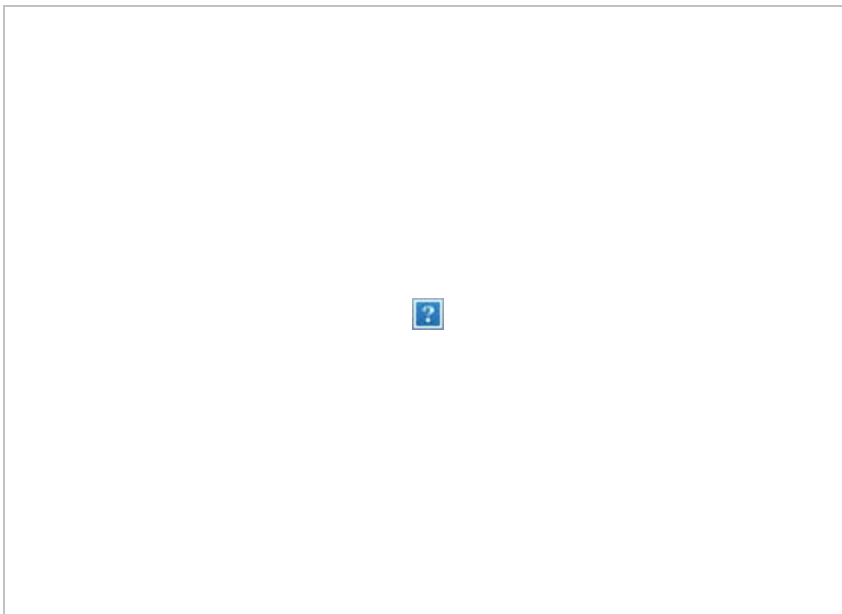

Good morning Nick,

When the Commission grants the exemption to the clearance rules it will issue an order that specifies the signage requirement. Right now, the draft order states:

1 These exemptions are subject to the following conditions:

(a) A sign indicating “No Clearance” must be posted on the northeast corner of the concrete platform facing approaching rail traffic.

(b) Notice of the close clearance must be posted in BNSF general order and included in the next timetable revision. BNSF must provide a copy of the updated general order to Staff within 60 days of the date of this order.

This should be consistent with what we discussed at our site visit in June. The order gives you a lot of flexibility in what type of sign you want to use. There are standard “no clearance” signs in the rail industry I’m assuming you’re familiar with. I can send some pictures of sample signs if you like.

If we need to change the language in the order let me know ASAP.

I have the OK from BNSF and this item will be back on the open meeting agenda for approval August 8.

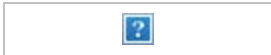

I was directed to the WUTC website by the BNSF in regards to clearance requirements and pursuit of a waiver of said requirements per the attached email. We have had our loading safety cage struck twice by an inbound locomotive so I am looking for concrete guidelines for remediation of the issue. We had been told that 18'0" was the requirements but have now been directed by BNSF that would only apply when rail tracks end within a building, which ours do not.

I am curious about the waiver process on that requirement (we would be able to clear the 18'0" but not the 22'6" stated) and if you or who within your organization I would work with on the process.
