After consultation with Washington Utilities and Transportation Commission ("WUTC") Staff, Cascade Natural Gas Corporation, herein referred to as Cascade, hereby submits the following supplemental information to amend its Certificate of Public Convenience and Necessity to Operate a Gas Plant for Hire in the West Richland Keene Road area located in Benton County, Washington.
