In accordance with the rules and regulations governing accounting for public service companies as set forth in Chapters 480-90-275 and 480-100-275, Puget Sound Energy ("PSE") is submitting herewith its Results of Operations and allocated rate base for the period ending December 31, 2019.

Additionally, pursuant to WAC 480-07-160, the Company requests that the enclosed Balance Sheets, Income Statements and Operating Revenue Sales Reports be accorded Confidential treatment because the year-end financial audit is not yet complete and the results for the period have not been publicly released and are still subject to change. At the time the Company submits its form 10-K, which is expected to be filed around March 1, 2020, these statements will no longer be confidential.
