Puget Sound Energy (“PSE”) hereby submits in connection with Docket UE-200970 a cover letter, a work paper, and the following tariff sheet to replace these documents that accompanied PSE’s December 2, 2020 initial filing, which was submitted under PSE’s Advice No. 2020-45. This filing includes the following portion of PSE’s WN U-60 tariff for electric service.

3rd Revision of Sheet No. 62-A - Substation and Related Equipment Capacity (Continued)

This filing corrects the tariff sheet revision code on Sheet No. 62-A and replaces the work paper that calculated the customer impact. PSE hereby amends the total Schedule 62 annual revenue impact from the initial amount of a decrease of \$38,707 to a total annual decrease of \$11,755. The annual revenue impact was recalculated to reflect updates to current lease amounts and additional updates of lease components for certain customers. The attached revised work paper reflects this change.

Additionally, PSE hereby submits a replacement cover letter. This substitution is being made to remove an erroneous reference to customer noticing being performed in accordance with the provisions of WAC 480-100-194. Customers taking service under Schedule 62 were contacted individually upon conclusion of PSE’s most recent General Rate Case (“GRC”) under consolidated Dockets UE-190529 and UG-190530 by their account managers to advise them of upcoming changes to rates and to update lease agreements. Upon approval of this filing, each customer will receive an updated lease agreement from their account manager to review and sign prior to their individual rate being updated.
