RE: Washington Utilities and Transportation Commission v. Job4Movers LLC Commission Staff's Response to Request for Payment Arrangement Dockets TV-220016 and TV-220017 (Consolidated)

Dear Ms. Maxwell:

On January 13, 2022, the Washington Utilities and Transportation Commission (Commission) issued a notice of intent to cancel the permit of Job4Movers LLC (Job4Movers or Company) and a notice of brief adjudicative proceeding in Docket TV-220016.

On January 20, 2022, the Commission issued a penalty assessment against Job4Movers in the amount of \$12,300 for violations of Washington Administrative Code (WAC) 480-15-555, WAC 480-15-560, and WAC 480-15-570 in Docket TV-220017.

On January 21, 2022, Job4Movers filed with the Commission its application for mitigation of the penalty. On February 3, Job4Movers submitted a proposed safety management plan. On February 10, Commission staff (Staff) filed its evaluation of the Company's safety management plan and response to the Company's request for mitigation.

On February 14, 2022, the Commission entered Order 01, Canceling Hearing; Consolidating Dockets; Approving Safety Management Plan; Upgrading Safety Rating; Imposing and Suspending Penalties (Order 01). Order 01 reduced the penalty to \$6,850 and suspended a \$3,500 portion of the reduced penalty for a period of two years, and then waived, subject to the conditions that: (1) Staff conducts a follow-up safety investigation at least six months from the effective date of Order 01, (2) Job4Movers not incur any repeat acute or critical violations upon re-inspection, (3) the Company maintains a conditional safety rating, and (4) Job4Movers pays the \$3,350 portion of the penalty that is not suspended or enters into a mutually agreeable payment arrangement with Staff within ten days of Order 01.

On February 16, 2022, Staff and Job4Movers came to a mutual agreement on a proposed payment plan, as follows:

Staff recommends the Commission grant the Company's request for payment arrangements. Job4Movers is aware that if it fails to pay any installment by the due date, the entire remaining balance, including the suspended penalty, will immediately become due and payable without further Commission order.
