**Re: Do Not Redocket – Electric Tariff Revision – Notice Verification
Docket UE-230138 (Advice No. 2023-09)**

Dear Ms. Maxwell:

Pursuant to WAC 480-100-198, Notice Verification and Assistance, Puget Sound Energy (“PSE”) is providing this statement that it has provided the attached notice, with regard to the above-referenced docket, in accordance with WAC 480-100-194, Publication of Proposed Tariff Changes to Increase Charges or Restrict Access to Services.

On March 1, 2022, PSE filed with the Commission a revision to its electric Schedule 62 Substation and Related Equipment Capacity. Seventeen electric customers would see an increase in their bills effective April 1, 2023, due to the effects of the proposed changes in this filing.

PSE posted the above-referenced filing in accordance with WAC 480-100-193(1), Posting of Tariffs for Public Inspection and Review; Web, Telephone, and Mail Access by posting on PSE’s web site coincident with the filing date. In addition, individual notice of this filing was completed in accordance with WAC 480-100-194(3), Reduced Publication with Shortened Notice to Individual Customers, in the form of a notice delivered to customers electronically.

PSE originally intended to file this revision to its electric tariff on February 28, 2023. Due to unforeseen circumstances, the filing was completed a day later on March 1, 2023. However, individual notice of this filing was sent on February 28, 2023, and a subsequent correct notice was sent to customers on March 1, 2023. A copy of both the notices that were emailed to each customer, on both February 28, 2023 and March 1, 2023, are attached.
