## IMPORTANT NOTICE FOR PUGET SOUND ENERGY CUSTOMERS ABOUT CHANGES IN ELECTRIC RATES

Puget Sound Energy (PSE) recently filed a request with the state Utilities and Transportation Commission (UTC) to adjust electric rates. The requested change is proposed to be effective on September 1, 2023.

Schedule 141CEI Clean Energy Implementation Tracker: A new tariff schedule that would allow PSE to recover the costs of its 2021 Clean Energy Implementation Plan (CEIP). This will recover the costs included in PSE's approved CEIP in Docket UE-210795 that are not recovered in other tariff schedules. Such costs may include, but are not limited to: distributed energy resource costs, public participation plan costs, costs of tracking and monitoring CEIP progress, and 0&M expense and capital expense for any projects that enable CEIP implementation. This filing proposes an overall increase in electric rates of 0.90%.

For customers who need help with their PSE electricity bills, various PSE bill assistance programs, including PSE Home Energy Lifeline Program (PSE HELP) and the Salvation Army Warm Home Fund, are available to qualified customers to assist with this Schedule 141CEI charge and other PSE charges.

The proposed overall average changes for electric customers are as follows:

Note: The figures above represent averages by rate schedule including the basic charge. Individual customers will see a change that is greater or lesser than what is shown, depending on the amount of usage. Most electric customers are billed monthly. Some electric customers are billed every other month. During the UTC's consideration of these proposed rates, other rates may change due to pending or previously approved rate filings.

The UTC will review each filing and has the authority to set final rates that may vary from PSE's requests, either higher or lower or structured differently, depending on the results of its review.
