*** Present provisions are:**
45 day notice to customers for all tariff changes per RCW 81.28.050.

*** Proposed changes are:**
Notify customers on the first bill as stated in WAC 480-70-271 (2)(a). This would occur March 1, 2024.

*** Explain why the company is proposing this tariff revision:**
The Company is proposing this Tariff revision due to a tip fee increase effective January 1, 2024. The rates were calculated and reviewed by Staff in TG-231007 and approved by the Commissioners on December 21, 2023. This filing is to update the Loose material Tariff rates on Item 150 that was impacted by this Tip Fee increase.

*** Explain why the Commission should allow this tariff revision to take effect with less than 30 days' notice (45 days' notice for solid waste):**

Staff reviewed the Company's calculation for increasing rates as a result of a Tip Fee Increase in TG-231007. These rates were reviewed and confirmed by Staff and just need to be included and implemented on the official Tariff. The Company is seeking to remedy this as soon as the next available billing date. The Company would like to notify customers on the next bill per WAC 480-70-271(2)(a)
