#### TO ALL INTERESTED PERSONS:

On May 30, 2025, Avista Corporation d/b/a Avista Utilities (Avista), PacifiCorp d/b/a Pacific Power & Light Company (PacifiCorp), and Puget Sound Energy (PSE) filed with the Washington Utilities and Transportation Commission (Commission) a report detailing the eligible renewable resources acquired for complying with their respective 2025 renewable resource targets.

These reports are required by the Energy Independence Act, Chapter 19.285 RCW, and WAC 480-109. WAC 480-109-210(3) provides that Commission Staff and all interested persons may comment on the utility's annual renewable portfolio standard report within 30 days of the utility's filing. The Commission will consider the reports and any comments it has received at a future open meeting.

Upon conclusion of its review of the renewable resource standard reports, the Commission will issue a decision determining whether the companies correctly calculated their 2025 renewable resource targets and complied with their reporting requirements.
