**AMENDMENT NO. 7 TO AGREEMENT
BETWEEN
VERIZON SELECT SERVICES INC. f.k.a GTE COMMUNICATIONS CORPORATION
AND VERIZON CORPORATE SERVICES GROUP INC. f.k.a.
GTE SERVICE CORPORATION d/b/a VERIZON SERVICES GROUP
AND VERIZON SERVICES CORP. AND TELESECTOR RESOURCES GROUP, INC.
d/b/a VERIZON SERVICES GROUP**

THIS AMENDMENT NO. 7 ("Amendment"), dated the 5th day of June, 2003, modifies the Agreement entered into on March 1, 1997, as amended, by and between Verizon Select Services Inc. f.k.a. GTE Communications Corporation ("VSSI") and Verizon Corporate Services Group Inc. f.k.a. GTE Service Corporation d/b/a Verizon Services Group on behalf of itself and its affiliates, Verizon Services Corp. on behalf of itself and its affiliates, and Telesector Resources Group Inc d/b/a Verizon Services Group on behalf of itself and its affiliates, for the provision of telecommunications services ("Agreement"). Verizon Corporate Services Group Inc., Verizon Services Corp. and Verizon Services Group are hereinafter referred to as "Customer".

1. **Modification.** In accordance with Paragraph of 15.0 of the Agreement, the Parties agree to amend the Agreement as follows:
 - a. Appendix A Description of Telecommunications Services & Pricing to the Agreement is amended and restated as follows:
 1. Schedule A-13 "Prepaid Calling Cards," attached hereto as Exhibit A to this Amendment, is hereby added to Appendix A of the Agreement.
 2. Schedule A-13 is hereby made part of Appendix A of the Agreement.
2. **Effective Date of Modification.** The prices for Prepaid Calling Card Services shown in Appendix A of the Agreement are effective for Prepaid Calling Card Services purchased by Verizon West Operating Companies and Verizon East Operating Companies and provided by VSSI pursuant to this Agreement during the period beginning December 1, 2000 through December 31, 2002.
3. **Termination.** The Parties entered into a separate agreement for telecommunications services on March 24, 2003, as amended on April 29, 2003 ("New Agreement"). The Parties hereby agree to terminate the Agreement effective July 1, 2003 and all services shall be purchased out of the separate agreement entered on March 24, 2003.
4. **Authority.** Each person whose signature appears below represents and warrants that he/she has the authority to bind the party on whose behalf he/she has executed this Amendment.
5. **Multiple Counterparts.** This Amendment may be executed in multiple counterparts, each of which shall be deemed an original, and all of which shall constitute but one and the same instrument.

Prepaid Calling Card Services are provided by VSSI at VSSI's prevailing market rate.

The following prevailing market rates are applicable for Prepaid Calling Card Services provided occasionally during the period from December 1, 2000 through December 31, 2002, by VSSI pursuant to this Agreement to the Verizon West Operating Companies and Verizon East Operating Companies listed in Appendix B to this Agreement.
