FROZEN SCHEDULE 22 DUAL FUEL SALES SERVICE

AVAILABLE:

To Non-Residential Customers, in all territory served by the Company under the Tariff of which this schedule is a part. Customer must have dual fuel equipment, and the fuel required for the operation thereof by October 15 of each year, to make possible the complete substitution of an alternate fuel for natural gas by means of an automatic fuel switching control. The automatic fuel switching control must be thermostatically actuated by outdoor temperature whenever the outdoor temperature is below 32 degrees Fahrenheit. Service to new customers, or an increase in MDDV to an existing customer, will not be available under this schedule on or after March 4, 1974.

SERVICE DESCRIPTION:

Service under this schedule is Interruptible Service under a written Service Agreement for a term of not less than one year. The dual-fuel equipment and associated control apparatus, and the installation thereof, shall be subject to approval by the Company. The outside temperature settings of such control apparatus shall be under the Company's exclusive control.
