Dear Director and Secretary Killip:

Puget Sound Energy (“PSE”) has identified minor, nonsubstantive typographical errors in the Prefiled Direct Testimony of Ned W. Allis, Exh. NWA-1T and the Confidential version of the Seventh Exhibit to the Prefiled Direct Testimony of Colin P. Crowley Exh. CPC-8HC. PSE would like to correct these errors for the record and is submitting replacement versions. The replacement version for Exh. NWA-1T corrects the cover page, and the replacement for the Confidential version of Exh. CPC-8HC fixes the header. None of the changes are to the substance of the testimony or an exhibit.
