This letter is to inform you of the progress made toward rulemaking for Electric System Reliability, to provide notice of an opportunity to file written comments on the proposed rule, and to invite you to participate in the formal proposed rule adoption hearing. The purpose of the proposed rule is to generate, and make available to the Commission, accurate and meaningful information about the reliability of electricity service to customers of electric utilities regulated by the Commission. These rules will allow the Commission to track trends in electric service reliability and to identify areas of special reliability concern, and will assist the Commission in its assessments of the adequacy of electric service provided to customers.

On January 11, 2001, the Commission authorized the filing of a Notice of Proposed Rulemaking (CR-102) with the Code Reviser. This action begins the final part of the rulemaking process, which includes a written comment period, a public adoption hearing, and a decision by the Commission.
