I am writing to you because it has not been possible to communicate with our city and port of Tacoma officials or Puget Sound Energy itself, despite our efforts. We recently learned that PSE would like to have ring fencing provisions removed and now is in mitigation. Next meeting on this issue will be July 29<sup>th</sup> at 9:30 am. We are concerned that this information has not been made public earlier, we only learned of it via public record request. We would like to understand how to get engaged in the process and have our voices heard.

Will there be a public comment period at the meeting? What format and how long? How come the hearing is not on your calendar? Several of us inquired and apparently this is not an item for the public calendar?

Why not? It potentially would affect 2 million PSE customers. We really don't want our wallets plundered behind our backs, or by a foreign owned investment group.
