- On May 5, 2005, PacifiCorp d/b/a Pacific Power & Light Company (PacifiCorp or the Company) filed with the Commission revisions to its currently effective Tariff WN-U-74, as described in paragraph 1 of the Commission's Complaint and Order No. 01 in this proceeding. The stated effective date for the revised tariff is June 5, 2005. PacifiCorp requests an increase in annual revenues from Washington operations of \$39.2 million, resulting in a proposed uniform increase in rates of 17.9 percent. The filing is based on a test period consisting of the twelve months ending September 30, 2004.
- Hearing in this matter is being held pursuant to Part IV of chapter 34.05 RCW pertaining to adjudicative proceedings, including but not limited to RCW 34.05.413, RCW 34.05.422, RCW 34.05.431, RCW 34.05.434, RCW 34.05.440, RCW 34.05.449, and RCW 34.05.452. The Commission has jurisdiction over this matter pursuant to Title 80 RCW, having legal authority to regulate the rates, services, and practices of electric utilities. Statutes involved, in addition to those previously cited, include those within chapters 80.01, 80.04 and 80.28 RCW relating to rates, including but not limited to RCW 80.01.040, RCW 80.04.020, RCW 80.28.020, RCW 80.28.030, RCW 80.28.070, RCW 80.28.090, and RCW

80.28.100. Rules involved include those within chapters 480-07 and 480-100 WAC.

- The ultimate issues include whether the proposed tariff revisions are fair, just, reasonable, sufficient, and in the public interest. The ultimate issues also include whether Pacificorp's current power cost rate on file and in effect with the Commission is fair, just, reasonable, and sufficient. These issues may include consideration of alternative rate design or structure. In accordance with the provisions of RCW 80.04.130, the burden of proof to show that the proposed tariff revisions are just and reasonable shall be upon the respondent.

- NOTICE IS FURTHER GIVEN That the parties should also be prepared to identify or schedule proposed dates for settlement conferences. The Commission will convene an initial settlement conference during or immediately following the prehearing conference. The settlement schedule will be incorporated in the schedule established in the prehearing conference order.

The Commission asks that petitions to intervene be made in writing prior to the hearing date, pursuant to WAC 480-07-355. Petitions to intervene may also be made orally at the hearing. Appearances will be taken. If any party or witness needs an interpreter or other assistance, please fill out the form attached to this notice and return it to the Commission. The time and place for the evidentiary hearings will be set at the prehearing conference or by later written notice.
