TO INTERESTED PERSONS:

This letter is to inform you of the status of the Commission's rulemaking to consider revisions to WAC 480-100-238, Least-cost planning, relating to electric companies, and WAC 480-90-238, Least-cost planning, relating to gas companies. This letter also provides notice of an opportunity to file written comments on the proposed rules and to participate in the formal rule adoption hearing.

On September 7, 2005, the Commission filed a Notice of Proposed Rulemaking (CR-102) in these dockets with the Code Reviser. This action begins the final part of the rulemaking process, which includes a written comment period, a public adoption hearing, and a decision by the Commission.

WRITTEN COMMENTS

The Commission requests that comments be provided in electronic format to enhance public access, for ease of providing comments, to reduce the need for paper copies, and to facilitate quotations from the comments. If you are unable to file your comments electronically or to submit them on a disk, the Commission will always accept a paper document.
