MEMORANDUM

- NATURE OF PROCEEDING: Docket UT-061625 involves Qwest Corporation's (Qwest) request for an alternative form of regulation (AFOR) pursuant to RCW 80.36.135.
- PROCEDURAL BACKGROUND: The Washington Utilities and Transportation Commission (Commission) approved, subject to condition, Qwest's request for an AFOR.¹ By Order 14 entered November 30, 2007, the Commission, among other things, accepted Qwest's partial compliance filing and required Qwest to submit a complete compliance filing by February 1, 2008.²
- Qwest timely filed its second compliance filing on December 31, 2007. On January 15, 2008, Public Counsel and the Commission Staff (Staff) timely filed comments. Staff's comments include a listing of clerical errors in Qwest's December 31, 2007, filing.
- 4 On January 16, 2008, Qwest filed a motion for leave to file a reply and revised tariff sheets in connection with other parties' comments. In Qwest's reply, it states that it will provide a copy of the catalog reflecting all changes to the AFOR compliance

filings, any additional agreed-to changes that aid in cross-referencing between the catalogs and tariffs, and changes to correct filing errors after the Commission has ruled on the final compliance filing.

- 5 **COMMISSION DECISION:** The Commission grants Qwest's motion for leave to file reply and revised tariff sheets. The reply does not raise new issues or present additional argument. Rather, it states Qwest's willingness to revise its compliance filing to be in accord with Staff's comments. The reply aids the Commission in rendering a decision on the compliance filing and should be permitted.
- The Commission concludes that it will aid in its review of the final compliance filing, particularly cross-referencing between the tariffs and catalogs, if it receives the corrections to the catalog prior to entering its order on the compliance filing. Accordingly, the Commission establishes <u>5:00 p.m., January 18, 2008</u>, as the deadline for Qwest to submit corrections to the catalog.
- 7 The Notice of Required Number of Copies entered February 8, 2007, requires filings to include an original plus 15 copies of all filings. The Commission does not require this number of copies of the catalog corrections. Qwest is required to submit an original and three copies of the catalog corrections.

<u>ORDER</u>

THE COMMISSION ORDERS:

- 8 (1) The motion for leave to file reply filed by Qwest Corporation is granted.
 - (2) By 5:00 p.m., January 18, 2008, Qwest Corporation is required to file all catalog corrections.
