Q. Please state your name and business address.

A. My name is Matthew R. Marcelia. My business address is 10885 NE 4th Street,

Q. By whom are you employed and in what capacity?

A. I am employed by Puget Sound Energy, Inc. (“PSE”) as Director of Tax.

Q. What are your duties as Director of Tax?

A. As Director of Taxes, I have the overall management responsibility for the tax department and direct all aspects of the company’s tax compliance, accounting for taxes, financial reporting of tax, and tax planning. My responsibility includes income taxes as well as state and local taxes. I report directly to the Vice President of Finance and Treasurer.

1 **Q. Briefly describe your education and relevant employment experience.**

2 A. I graduated from the University of Washington in 1990 with a B.A. in Business
3 Administration – Accounting. I also graduated from the University of Colorado,
4 Boulder in 1992 with an M.S. in Accounting – Taxation.

5 I am a licensed Certified Public Accountant in the State of Washington. I am a
6 member of the Washington Society of Certified Public Accountants, the
7 American Institute of Certified Public Accountants, the Edison Electric Institute
8 Taxation Committee, and the Tax Executive Institute.

9 After graduating from the University of Colorado, Boulder in 1992, I started with
10 PricewaterhouseCoopers in Denver, Colorado. In 1997, I relocated to the
11 PricewaterhouseCoopers office in Seattle, Washington. In 1998, I became a Tax
12 Manager at the PricewaterhouseCoopers office in Seattle, Washington.

13 In May 2003, I left PricewaterhouseCoopers to become Manager of Taxes at PSE.
14 I was promoted to Director of Taxes at PSE in January 2005 and have held that
15 position since then.
