The Northwest Industrial Gas Users ("NWIGU") respectfully submits these initial comments on the rulemaking in Docket No. UG-010522 to establish the fee methodology to fund the pipeline safety program as required by Substitute Senate Bill 5182 ("SSB 5182"). On April 25, 2001, the Washington Utilities and Transportation Commission ("WUTC" or "Commission") initiated this rulemaking by filing a Preproposal Statement of Inquiry ("CR-101") with the Code Reviser. The intent of SSB 5182 is to ensure a sustainable, comprehensive pipeline safety program and establish permanent funding through the collection of a regulatory fee. The Commission has invited initial comments which must be filed by May 10, 2001.

NWIGU is a nonprofit association comprised of thirty-one industrial users of natural gas with major facilities in the states of Washington, Oregon and Idaho. Some NWIGU members own gas facilities that directly connect their plants to the interstate pipeline. Therefore, NWIGU has a direct and substantial interest in these proceedings.

NWIGU plans to participate in the workshop on May 17, 2001, to discuss the proposed rule language for the fee methodology and all future workshops or proceedings. NWIGU would also like to submit additional comments after we receive and have had an opportunity to review Staff's draft rulemaking proposal.
