PASSENGER RULES

- 1- Island Airporter LLC reserves the right to refuse service to anyone an Island Airporter LLC employee believes would create an unsafe or unpleasant trip for the other passengers or themselves.
- 2- Passengers are required to wear clothing, which reasonably covers themselves along with footwear.
- 3- Passengers who have been drinking or who are suspected of having drunk excessively or having used or are using drugs, will not be allowed to board.
- 4- No consumption of Alcohol or drugs permitted on the Bus.
- 5- No animals may be brought onboard, unless it is a licensed service animal with pre-authorization by Island Airporter LLC, and then the animal is to be kept off all of the seats.
- 6- No weapons may be transported in the passenger compartment of the bus. All weapons must be claimed and unloaded then loaded into the luggage compartment for transport..
- 7- Children under the age of 16 are only allowed to travel alone with permission slip from the legal guardians.
- 8- Carrier will not be liable for delays caused by accidents, break downs, bad conditions of roads, delays by the Washington State Ferry System, snow storms or other conditions beyond the control of the carrier and does not guarantee arrival at, or departure from, any point at any specific time.
