1. The Commission finds good cause to support the request and authorize the proposed changes to become effective with Less Than Statutory Notice on: July 1, 2006
2. The proposed changes will expire on: September 30, 2006
3. The temporary .79% fuel surcharge in all rates and chareges is the result of increased fuel costs incurred by the company during the months of March, April and May 2006, to be collected from customers as follows:

For customers who are billed monthly for services in arrears, the fuel surcharge applies to all services provided in the months of July 2006, August 2006, and September 2006.

Customers who are billed quarterly for services – one month in arrears, current and one month in advance:

September 2006	September, October and November 2006
