1. The Commission finds good cause to support the request and authorize the proposed changes to become effective with Less Than Statutory Notice on: October 1, 2006
2. The proposed changes will expire on: December 31, 2006.
3. The temporary 1.17% fuel surcharge in all rates and charges is the result of increased fuel costs incurred by the company during the months of June, July and August 2006, to be collected from customers as follows:

For customers who are billed monthly for services in arrears, the fuel surcharge applies to all services provided in the months of October 2006, November 2006, and December 2006.

Customers who are billed quarterly for services – one month in arrears, current and one month in advance:
