Recommendation:

Background:

Today's presentation allows customers or other interested parties to comment on the proposed rates in Docket TG-070749. No action is required by the commission. Staff will make its recommendation to the commission at the open meeting on May 23, 2007.

On April 16, 2007, Rabanco, LTD, d/b/a Allied Waste Services of Kent, Rabanco Companies, and Sea-Tac Disposal, G-12, (Rabanco or company), filed a new Tariff 26 to combine its Tariff 25 and its Tariff 20 (adopted from Waste Management of Washington, Inc). The filing proposes to increase some garbage rates and to decrease others. Residential recycling and yard waste rates increase under the proposed rates. The company serves 11,600 regulated solid waste customers in southern King county. The proposed filing generates about \$375,418 (9.4 percent) annually.

As of May 4, 2007, no customers had commented on this filing. The time between the open meeting and when the company sent out the customer notices at the end of April is very short and customers may not have had time to contact the commission.
