- I On January 16, 2008, the Washington Utilities and Transportation Commission (Commission) notified Dutchman Marine, LLC (Dutchman Marine), Seattle Harbor Tours Limited Partnership (Seattle Harbor Tours), and Seattle Ferry Service, LLC (Seattle Ferry Service) of its intention to cancel their individual certificates for failure to comply with Revised Code of Washington (RCW) 81.84 and Washington Administrative Code (WAC) 480-51. The Notice provided that any certificate holder wishing to request a hearing or otherwise contest cancellation had to do so in writing by February 15, 2008.
- 2 On February 8, 2008, Larry Kezner of Seattle Ferry Service filed a letter with the Commission acknowledging failure to submit a progress report in 2007. The letter went on to explain the operational challenges facing Seattle Ferry Service, request a modification of the company's certificate to eliminate one ferry run and confirm continuation of another. Mr. Kezner's letter closed by agreeing to participate in a hearing in this matter, if required.
- 3 On February 12, 2008, Daniel E. Dolson of Dutchman Marine filed a letter with the Commission asking for a hearing. Mr. Dolson indicated that "Dutchman Marine wishes to continue to pursue implementation of passenger-only ferry service on Lake Washington and Lake Union," further noting that cancellation of it certificate "would severely hinder the development of the service."

- Seattle Harbor Tours failed to respond to the Notice. Therefore, based upon the unchallenged factual allegations set out in the Notice (¶¶ 14, 16, 17 and 18), the
- Commission will cancel Seattle Harbor Tours' certificate No. BC-124 by further Commission order.
