- 1 Certificate of Public Convenience and Necessity G-171 stands in the name of Eric K., Zachary C., and Keith C. Holt, d/b/a Newman Lake Garbage Service, and authorizes the service therein set forth.
- 2 Certificate of Public Convenience and Necessity G-104 stands in the name of Ada-Lin Waste Systems, Inc., d/b/a Sunshine Disposal & Recycling, and authorizes the service therein set forth.
- Joint Application TG-091431 has been filed requesting authority to transfer all rights under said Certificate G-171, held by Eric K., Zachary C., and Keith C. Holt, d/b/a Newman Lake Garbage Service, to holder of Certificate G-104, held by Ada-Lin Waste Systems, Inc., d/b/a Sunshine Disposal & Recycling.
- The application appeared on the September 11, 2009 application docket and was unopposed.
- The Commission, having considered the application and being fully advised, finds that it will not be detrimental to interests of the public and that the transferee is fit, willing and able to conduct the involved transportation service.

ORDER

THE COMMISSION ORDERS:

- The application in Docket TG-091431 to transfer all rights under solid waste certificate G-171 from Eric K., Zachary C., and Keith C., Holt, d/b/a Newman Lake Garbage Service, to Ada-Lin Waste System, Inc., d/b/a Sunshine Disposal & Recycling, is hereby granted, conditioned upon compliance with the provisions of RCW 81.77 and the rules relating to solid waste collection companies
- 7 (2) Certificate of Public Convenience and Necessity G-171 be cancelled.
- 8 (3) Certificate of Public Convenience and Necessity G-104 be amended as per Appendix A.
- 9 (4) Temporary Certificate of Public Convenience and Necessity TCG-63721 be cancelled.
- 10 (5) Eric K., Zachary C., and Keith C., Holt, d/b/a Newman Lake Garbage Service, G-171, file an Annual Report for the period January 1, 2009, to date of discontinuance, and remit annual regulatory fee based on the gross operating revenue from garbage collection operations.
- All parties interested should take notice that the Commission in granting authority for the transfer of rights under a solid waste certificate does not necessarily approve the amount involved in the transaction, nor does it bind itself to recognize such amount in placing a value for ratemaking purposes on the property of the certificate holder.
- The Commission further orders that the tariff filed in connection with this application will become effective at 12:01 a.m. on the day following the service date of this order.
- The Commission has delegated authority to the Secretary to enter this Order under RCW 80.01.030 and WAC 480-07-905(2)(c).

You may seek Commission review of this decision. You must file a request for Commission review of this order no later than fourteen (14) days after the date the decision is posted on the Commission's Web site.

The Commission will schedule your request for review by issuing a notice of hearing to be held before an administrative law judge. The Commission, at its discretion, may consider your request for review in an adjudicative proceeding under RCW 34.05 Part IV, or in a brief adjudicative proceeding under RCW 34.05.482 through .494. Following hearing, the administrative law judge will enter an initial order. If you wish to seek review of the initial order, you may file a petition for administrative review under RCW 34.05.464, or if the matter is heard in a brief adjudicative proceeding, under RCW 34.05.491.

The Commission will grant a late-filed request for review only on a showing of good cause, including a satisfactory explanation of why the person did not timely file the request. A form for late-filed requests is available on the Commission's Web site.

This notice and review process is pursuant to the provisions of RCW 80.01.030 and WAC 480-07-904(2) and (3), and WAC 480-07-905, as amended effective September 22, 2008.
